**The National Congress of Black Women, Inc. (NCBW) is a 501 (c) 3 non-profit organization whose Purpose/Mission Statement/Goals are as follows:**

- Serve as a member unit of a National non-partisan, independent, political organization to provide for participation of African American women in the political process.
- Encourage African American women to engage in political activities beginning with registering to vote.
- Confront forces in the cultural, economic and community environment that threaten the physical, mental and moral well-being of African American youth, especially those most at risk.
- Develop and encourage African American women to run for office at all levels.
- Develop and advocate public policy positions, which advance the political, social, educational and economic interests of African American women, their families and communities.
- Encourage the appointment of African American women at all levels of government and political parties.
- Empower African American women to act as role models for the next generation of leaders.

**Program Initiatives**

**HEALTHCARE REFORM** – Preventable disease and disability have a profound on the health of African Americans in the greater Los Angeles communities a sell as the world. **MEMBERSHIP COMMITTEE** – Establish each year annual goals to recruit and retain active, contributing members. It shall create and disseminate all materials concerning membership, such as application forms, membership cards, and any other essential materials.

**BYLAWS COMMITTEE** – Prepare necessary amendments after study of the bylaws. Receive any changes or amendments proposed by members of the Chapters. Reviews all forms related to the LAC to ensure National and Local compliance.

**LEGISLATIVE COMMITTEE** – Overview all legislation, both state and federal, which may have an effect on women. It shall explore and recommend positions the Chapter should take on various legislative or political issues. It shall secure legislative financial support for the Chapter from local, state and national resources.

**PUBLICITY COMMITTEE** – Keep the public aware of the work of the Chapter through frequent informative news releases and by other means.

**BUDGET COMMITTEE** – Prepare and review the budgets and act as custodians of finances.

**FUNDRAISING COMMITTEE** – Develop and implement fundraising programs.

**HEALTH COMMITTEE** – Throughout the year, physicians and members in health-related fields educate the community on health issues that impact African Americans.
